#### **Company Profile**

The Company Profile has been updated with a fresh new look that allows for members to easily access the information they require.

**Rating system** which will be determined by G7N and can be increased by improving your involvement within the network.

**G7N Risk** will be directly linked to the financial protection system, the algorithm we have in place will determine the risk of the company by the number of outstanding and overdue invoice they have. This will allow members better visibility when giving companies credit and will also allow G7N Management to better protect fellow members against delayed payments.

Office Contacts have now moved to the right allowing for quick access to all contact details, this is if you prefer not to use the G7N Quote System.





#### **Notifications**

We have included the notification feature to improve communication between member to member as well as network management to member. You will be notified every time an announcement is sent out, departed members, an invoice is uploaded against you, any outstanding invoices that are about to become overdue, overdue invoices and paid invoices.

#### **Financial Protection System**

The Financial Protection System has been improved for better visibility and interpretation of your invoices uploaded into the system. Your invoices are now categorized between Overdue Outstanding and Paid Invoices.

First you need to <u>upload the invoices</u> that you issue into the system by clicking <u>Enter Invoice</u> and filling up the fields in blank with the details that your invoice has. (Remember no longer than 5 days of their issue date)

All invoices are directly <u>connected to your notifications</u>. After the upload, the member that has been assigned to particular invoice will get a notification advising that you have uploaded invoice. If this is not paid on time, the other member will receive a 2nd notification informing that the invoice is overdue.

This will also be connected to their <u>G7N Risk rating</u> on their company's profile, which can affect their image within the G7N community.

These procedures have been put in place to create a better awareness and reduce any risk within the network.
